**The Agricultural Subsidies and  
Grants Schemes (Appeals) (Wales)  
(Amendment) Regulations 2014**

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations make further amendments to the Agricultural Subsidies and Grants Schemes (Appeals) (Wales) Regulations 2006, S.I. 2006/3342 (W. 303). The amendments update the list of European Union legislation covered by S.I. 2006/3342 (W. 303) as amended by S.I. 2007/2900 (W. 251) and S.I. 2010/1807 (W. 175).

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations as the amendments covered by these Regulations relate to existing arrangements for appeals.

The Welsh Ministers are designated<sup>(1)</sup> for the purposes of section 2(2) of the European Communities Act 1972<sup>(2)</sup> in relation to the common agricultural policy of the European Union.

These Regulations make provision for a purpose mentioned in that section and it appears to the Welsh Ministers that it is expedient for any reference in these Regulations to EU instruments to be construed as a reference to those instruments as amended from time to time.

The Welsh Ministers make these Regulations in exercise of the powers conferred by section 2(2) of, and paragraph 1A of Schedule 2 to, the European Communities Act 1972.

**Title, application and commencement**

**1.—**(1) The title of these Regulations is the Agricultural Subsidies and Grants Schemes (Appeals) (Wales) (Amendment) Regulations 2014.

(2) These Regulations apply in relation to Wales.

**Amendments to the Agricultural Subsidies and Grants Schemes (Appeals) (Wales) Regulations 2006**

2.—(1) The Agricultural Subsidies and Grants Schemes (Appeals) (Wales) Regulations 2006<sup>(1)</sup> are amended as follows.

“**18.** Regulation (EU) No 1305/2013 of the European Parliament and of the Council of 17 December 2013 on support for rural development by the European Agricultural Fund for Rural Development (EAFRD)<sup>(2)</sup>.”

**19.** Regulation (EU) No 1306/2013 of the European Parliament and of the Council of 17 December 2013 on the financing, management and monitoring of the common agricultural policy<sup>(3)</sup>.
